**CONDITION FOR PITCH RESERVATION :**

To confirm any reservation a deposit of 30% is required. The full amount is payable on arrival. Confirmation of the booking will be sent within 10 days after receiving your deposit which will be deducted from your total bill. Reservation is non transferable. Only registrars campers and occupants can occupy the rental place. All pitch occupants must respect the campsite rules.

The pitch is available starting midday and ends the day after at 11 :30am. Pets are permitted with current vaccination certificates with extra charge.

A daily tourist tax is due : 0.39 euro/person older than 17 years old.

There will be no reduction of price for any delay of arrival or earlier departure. If for any reason you can't fulfill your reservation without notification, the place becomes available after 24h for re-letting and there will be no refund.
