

PITCH RESERVATION CONTRACT

Please print this contract and send it back to the camping by mail (info@camping-martinet.com) or by post.

CONDITION FOR PITCH RESERVATION :

To confirm any reservation a deposit of 30% is required. The total amount is due 30 days before arrival. Confirmation of the booking will be sent within 10 days after receiving your deposit/payment. Reservation is non transferable. Only registrars campers and occupants can occupy the rental place. All pitch occupants must respect the campsite rules.

The pitch is available starting 2pm and ends the day after at 11 :30am. Pets are permitted with current vaccination certificates with extra charge. Maximum 6 persons are allowed per pitch.

For **FreeCamp pitches**, a **deposit of 150 eur**, only in cash, is to be left on arrival at the reception. A daily tourist tax and eco tax is due : 0.50 euro/person older than 17 years old.

There will be no reduction of price for any delay of arrival or earlier departure. If for any reason you can't fulfill your reservation without notification, the place becomes available after 24h for re-letting and there will be no refund.
